WHAT THIS REPORT CONTAINS: Special issue Musk vs Brazilian Judiciary is the result of the collection of selected terms on closed list dashboards in the period from 04/04/2024 to 11/04/2024, on the social media platforms Facebook, Instagram, YouTube, X and TikTok categorized according to political spectrum and classified in order of relevance. Next, the volumes of data collection, selection and categorization are presented. The list of terms in the collection list is:

1. Musk

2. Moraes

3. STF

4. TSE

5. dictatorship

6. censorship

7. judiciary

In the period analyzed by this report, each term was mentioned on the social media platforms by the selected groups (Far-Right, Progressive, other political actors) in the quantity indicated in the table below:



Overview

Posts collected by political ideology



A total of 2,670 posts were collected on Facebook, 2,473 on Instagram, 1,236 on YouTube, 471 on X and 91 on TikTok, with a total primacy of the far right on YouTube (74%), TikTok (74%) and Instagram (64%). The far right still dominates the agenda on X (56%) and Facebook (53%), the latter being the only social media on which the progressive field has managed to maintain a considerable level of posts (44%).

We also analysed the average number of interactions per post from each political ideology on each social media platform to understand whether the dominance of the far right in terms of the number of posts was also reflected in the number of interactions with these posts, in other words, whether the high number of posts was accompanied by a high level of interactions. We found that across all social media, the average number of interactions per far-right post was higher than that of the progressive field and other political actors. We highlight the average of 9,000 interactions for Instagram posts and 8,000 for YouTube.

The high volume of posts from the far right, accompanied by the highest rate of interactions per post, reflects a moment when the current agenda was under the narrative control of this political field during the period analyzed. It is therefore important to understand which narratives were used during this period, and which framework the far-right used.



2. NARRATIVES

MAIN NARRATIVES SUPPORTING ELON MUSK

CRITICIZING MORAES: Tweets by Elon Musk and Michael Shellenberger criticizing Judge Alexandre de Moraes and denouncing the alleged censorship imposed by the judge on the former Twitter account during the 2022 elections have inflamed the discourse against the judge. Moraes was accused of monitoring, censoring and violating the freedom of expression of deputies and influential figures from the conservative field, which, according to Shellenberger and those who echoed the narrative, could be categorized as interference and manipulation of the outcome of the 2022 presidential elections. In this sense, the resignation, impeachment, and imprisonment of Judge Moraes was covered by conservatives on social media platforms, echoing Musk's statement that Moraes should be tried and pay for his crimes. Prominent in this narrative were congressmen-elect Marcel Van Hattem (NOVO-RS), Nikolas Ferreira (PL-MG), Gustavo Gayer (PL-GO), Kim Kataguiri (UNIÃO-SP), Eduardo Bolsonaro (PL-SP) and Bia Kicis (PL-DF). In this narrative, Judge Alexandre de Moraes is seen as the head of a judicial dictatorship that censors, represses and imprisons its opponents.



BRAZIL IS A DICTATORSHIP: As a result, a narrative is being consolidated, the embryo of which is the 2022 presidential election: that Brazil is no longer a democracy, but a disguised dictatorship that is increasingly showing its true face. In this reading of reality, Lula's government would be a legal facade for the real power: the judiciary. In November and December 2022, these were the arguments used to call for a coup d'état, first with Article 142, then with military intervention. Now, this narrative that Brazil is a dictatorship has been reinforced by Elon Musk and echoed by far-right parliamentarians and influencers.

MAIN NARRATIVES CRITICAL OF ELON MUSK

CONSPIRACY OF THE INTERNATIONAL RIGHT: In the progressive field, the whole week's developments, which began with the Twitter files and culminated in Elon Musk's publications of frontal attacks against the Brazilian judiciary, were understood as an articulated attack by the international far-right camp. This articulation targets Brazil because of the interests of the political field to consolidate its position in Latin America, with Brazil as a key part of this project. Also at stake would be the creation of a fact that could compromise the integrity of the courts with public opinion, with the power to prevent Bolsonaro's arrest and remove his ineligibility. Musk's posts, which claim that the 2026 election is a crucial point, reinforce this narrative. The fact that Brazil is one of the first countries to hold those who spread disinformation criminally responsible and the 08/01 trials are also cited as reasons for the billionaire and the far right's frontal attack on the country.





TRAITORHOOD: Critics of Elon Musk interpreted the actions of the billionaire and Shellenberger as an attempt to interfere in Brazilian domestic politics. In this sense, Brazilian politicians who supported Musk's intervention were called traitors to the motherland. The contradiction between those who usually call themselves "patriots" but celebrate the interests of a foreign billionaire's intervention in the country was also pointed out. Finally, the contradiction between Musk and Brazilians who declare Brazil to be a dictatorship that censors its opponents, but do not oppose, for example, the Saudi regime, was pointed out, highlighting specific interests in Brazil.


3. TELEGRAM

From a sample of 150 <u>Telegram</u> channels and groups, we collected a total of 22,777 messages between April 4 and 11, 2024. The table below shows that the **topic was present in more than 70% of the groups and channels**. Taking all the terms together, we reached a **total of 2,662 messages in 119 channels and groups**, indicating a broad connection between the terms in the debate on the subject on the messaging app.



Highlights include mentions of freedom of expression, the Twitter Files Brazil, Elon Musk's speeches, Michael Shellenberger's statements, the United States, the Fake News Inquiry and other figures such as Allan dos Santos, Nikolas Ferreira and Felipe Neto.



In terms of circulating content on the topic, the channel with the most posts was **Pleno News** (12,300 subscribers) with 105 posts, and it's important to note that **Leandro Ruschel**'s channel (30,500 subscribers) was in 3rd place with 87 posts. In terms of views, the group **Especulando os Fatos (Oficial)** (8.9 thousand members) led the way with 1.3 million views in 30 posts on the subject, the channel **O INFORMANTE** (117 thousand subscribers) with 591.2 thousand views in 20 posts and the channel **SELVA & AÇO** (38.7 thousand subscribers) with 464.5 thousand views in 80 posts. This **highlights the potential for the rapid and widespread dissemination of messages on Telegram**.





3.1 MAIN THEMES

On Telegram, the same narrative axes of support for Elon Musk as mentioned above were identified, including criticism of Alexandre Moraes, accusations of "censorship" and "dictatorship" in Brazil and praise for Musk. The content published on Elon Musk's own profile continues to circulate constantly and widely on the platform. In this regard, the claim that Musk's accusations had reached the US Congress had particular repercussions. In addition, the narrative that there is great international commotion and support for the "situation in Brazil" (referring to allegations of censorship and dictatorship) continues to circulate. 

DISCLOSURE OF THE ISSUE IN PARLIAMENTARY COMMITTEES: On Tuesday (9) the approval of a motion to praise Elon Musk for "standing up to censorship" in the Public Security Committee of the Chamber of Deputies was widely publicized. On Thursday (11) there was widespread coverage of a session of the Senate Committee on Communication and Digital Law, especially through news reports and videos with cuts of speeches during the session. The speeches of Michael Shellenberger and David Ágape were particularly noteworthy, as they focused on "censorship in Brazil" and portrayed Moraes as a "dictator". Related to the theme, several messages attacked traditional media outlets, such as CNN Brasil and Globo, claiming that they were criticizing Musk for being aligned with Lula.



4. FINAL CONSIDERATIONS

From April 4 to 11, 2024, the Instituto Democracia em Xeque analyzed the dynamics of social media platforms highlighting the clash between Elon Musk and the Brazilian judiciary, specifically in relation to Judge Alexandre de Moraes. Pro-Musk narratives emphasized criticism of Alexandre de Moraes, accusing him of censorship and interference in the 2022 elections, as well as referring to Brazil as an alleged dictatorship. Conservative parliamentarians and influencers aligned with the far right reinforced these views, highlighting Musk as a defender of freedom against what they call a "dictatorship of justice". On the other hand, the progressive camp criticized Musk's actions, accusing him of acting in accordance with a coordinated attack by the international far right to undermine Brazilian sovereignty and interfere in domestic affairs. The messaging network Telegram played an active role in the dissemination of far-right narratives, including the organization of events and debates, the dissemination of the presence of Brazilian parliamentarians in the European Parliament and live videos and spaces, and the narrative that there is great international excitement and support for the "situation in Brazil". The far right was the political field that moved this debate the most, both in terms of the amount of material produced and the interactions achieved.
